DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

OWNER OF THE VEHICLE (JOHNNY SMITH D.O.B. 8/7/71) AND WAS ABLE TO PULL UP HIS DRIVERS LICENSE PHOTO. DURING THIS TIME WE FOLLOWED THE VEHICLE AS IT TURNED INTO THE PARKING LOT OF 5010 AIRPORT PULLING ROAD (WAL-MART). WE WATCHED AS THE VEHICLE PARKED AND THE DRIVER EXITED. WE WERE ABLE TO IDENTIFY THE DRIVER AS THE REGISTERED OWNER (JOHNNY SMITH D.O.B. 8/7/71) BY COMPARING THE SUBJECT WHO EXITED THE VEHICLE (DRIVER) TO THE DAVID PHOTO.

WE THEN MADE CONTACT WITH THE SUBJECT. I IDENTIFIED MYSELF AS CP. ORR WITH THE COLLIER COUNTY SHERIFFS OFFICE AND ASKED THE SUBJECT IF I COULD SPEAK WITH HIM FOR A MOMENT. THE SUBJECT ASKED WHY? I THEN INFORMED HIM THAT HE HAD AN OUTSTANDING WARRANT FOR HIS ARREST. THE SUBJECT STATED THAT HE DID NOT KNOW WHAT I WAS TALKING ABOUT AND HANDED ME HIS DRIVERS LICENSE CONFIRMING HIS IDENTITY AS JOHNNY SMITH D.O.B. 8/7/71.

I THEN HAD DISPATCH DO AN NCIC/FCIC CHECK ON THE SUBJECT. THE CHECK REVEALED THE OUTSTANDING WARRANT OUT OF JACKSONVILLE SHERIFF'S OFFICE. I THEN ASKED DISPATCH TO CONFIRM THE WARRANT. A FEW MOMENTS LATER DISPATCH ADVISED ME THAT THE WARRANT WAS CONFIRMED.

DUE TO THESE CIRCUMSTANCES JOHNNY WAS PLACED UNDER ARREST FOR THE OUTSTANDING WARRANT. HE WAS PLACED IN HANDCUFFS DOUBLE LOCKED AND TRANSPORTED TO NJC.

THE WARRANT NUMBER BEING 2008 020256 AFF WITH THE DATE OF THE WARRANT BEING 12/15/2008
