ARRESTED CO-DEFENDANTS

DEFENDANT DID THE FOLLOWING ACT(S) WHICH CONSTITUTE A VIOLATION OF THE LAW (ELEMENTS OF THE CRIME / PROBABLE CAUSE STATEMENT)

ON NOVEMBER 3, 2009 WHILE ON DUTY AT [REDACTED] HS I WAS CONTACTED BY THE DEAN OF DISCIPLINE [REDACTED], WHO ADVISED THAT HE HAD A FEMALE [REDACTED] IN HIS OFFICE AND NEEDED TO HAVE ME MEET WITH HER. UPON ARRIVAL I MET WITH [REDACTED] AND [REDACTED] ADVISED THAT SHE HAD BEEN RAPED THE NIGHT PRIOR BY ROBERT LYNN WHILE [REDACTED] ADVISED THAT SHE WAS HANGING OUT INT [REDACTED] ROOM WITH [REDACTED] AND ROBERT. SHE STATED THAT WHILE AT [REDACTED] HOUSE, ROBERT STARTED TO TOUCH HER. SHE STATED THAT SHE TOLD ROBERT TO STOP. SHE THEN STATED THAT ROBERT KEPT TRYING TO TAKE HER PANTS OFF AND WEN HE FINALLY DID SHE SAID HE STUCK HIS FINGER IN HER. SHE THEN STATED THAT HE THEN STUCK OTHER THINGS IN HER. [REDACTED] STATED THAT [REDACTED] TRIED TO STOP ROBERT BY TELLING HIM TO STOP.

I THEN IMMEDIATELY MADE CONTACT WITH SGT. STEFAN LOEFFLER #1436 AND HE STATED THAT HE WOULD HAVE A DETECTIVE RESPOND RIGHT AWAY. DETECTIVE SCOTT PETERSON #2301 RESPONDED AND I WAS PRESENT DURING HIS INITIAL INTERVIEW WITH ROBERT LYNN. PETERSON MADE CONTACT WITH THE FAMILY AND ADVISED THEM OF AN INCIDENT THAT OCCURED INVOLVING ROBERT. ROBERT STATED THAT [REDACTED]

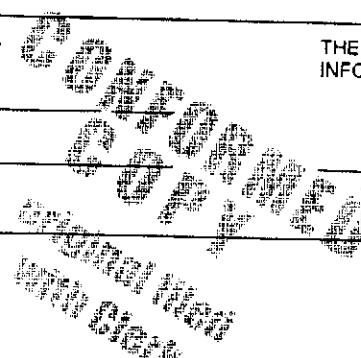
DETECTIVE PETERSON ADVISED ME TO TRANSPORT [REDACTED] TO THE CHILDREN'S ADVOCACY CENTER FOR AN INTERVIEW REGARDING THE INCIDENT.

I WAS CONTACTED BY PETERSON AND HE ADVISED THE FOLLOWING STATEMENT:

"SHE WAS IN [REDACTED] BEDROOM WITH ROBERT AND BRADLEY. SHE AND [REDACTED] WERE SITTING ON THE BED AND ROBERT WAS STANDING UP. ROBERT PULLED DOWN HIS ZIPPER AND UNBUTTONED HIS PANTS EXPOSING HIS PENIS TO HER. HE PUT HIS PENIS IN HER FACE AND TOLD HER TO PUT IT HER MOUTH. SHE SAID NO AND TURNED HER HEAD AWAY FROM HIM. HIS PENIS BRUSHED AGAINST HER CHEEK AS SHE PUSHED HIM AWAY. SHE WAS LYING ON HER SIDE ON THE BED AND ROBERT WAS LYING UNDER THE COVERS. HE GRABBED HER HAND AND PLACED IT ON HIS PENIS OVER HIS JEANS. SHE PULLED HER HAND AWAY AND HE STARTED RUBBING HIS HAND OVER HER SIDE AND LEG. HE THREW THE COVERS OVER HER LEGS AND TRIED TO PULL HER PANTS OFF. SHE TOLD HIM TO STOP AND TRIED TO KEEP HER PANTS ON BY HOLDING THEM AND KICKING HIM. ROBERT GOT HER PANTS OFF AND INSERTED HIS FINGERS INTO HER VAGINA. ROBERT THEN TOOK HIS PANTS OFF AND GOT ON TOP OF HER. HE HELD HER HANDS ABOVE HER HEAD AND TRIED TO PLACE HIS PENIS INSIDE HER VAGINA BUT WAS UNSUCCESSFUL. ROBERT'S PENIS ONLY TOUCHED HER ON THE OUTSIDE OF HER VAGINA. SHE PUSHED ROBERT OFF OF HER, GOT DRESSED, WENT HOME AND TOOK A SHOWER. [REDACTED] HAD TOLD ROBERT TO STOP, BUT HE HAS PHYSICAL AILMENTS THAT WOULD PREVENT HIM FROM PHYSICALLY INTERVENING. [REDACTED] WAS INTERVIEWED AND PROVIDED A VOLUNTARY SWORN TAPED STATEMENT TO WITNESSING [REDACTED] TELL ROBERT TO STOP INITIALLY AND THEN SHE DID NOT SAY STOP ANYMORE SO HE THOUGHT IT WAS OKAY WITH HER AT THAT POINT. [REDACTED] DID SAY THAT HE WITNESSES ROBERT DIGITALLY PENETRATED [REDACTED] VAGINA AND TRIED TO PUT HIS PENIS INSIDE HER. [REDACTED] SAID THAT HIS PARENTS CAME INTO HIS ROOM TO CHECK ON THEM APPROXIMATELY SIX TIMES WHILE [REDACTED] AND ROBERT WERE IN HIS BEDROOM. BASED ON THE ISSUE OF WHETHER THERE WAS CONSENT OR NOT, ROBERT WILL BE CHARGED WITH LEWD AND LASCIVIOUS MOLESTATION AS OPPOSED TO SEXUAL BATTERY."
